SUMMER CAMP ENROLLMENT POLICIES

- There is limited enrollment in each class. Class assignments will be made on a first come, first served basis.
- If registering for one summer session, the Registration Fee and full tuition payment must be received at the time of registration to confirm your child's enrollment.
- If registering for two or more sessions, you may turn in your forms and pay the Registration Fee and the payment for Session I during registration. Payment for the remainder of the sessions will be due by May 3, 2010.
- All completed forms and fees must be returned to St. Andrew's Children's Place by May 3, 2010. After this date we will begin filling vacancies from the Wait List.
- If registering after May 3, 2010, completed forms must be returned and **all summer fees** must be paid at the time of registration to confirm your child's enrollment.
- Summer Camp fees are **non-refundable and non-transferable under any circumstances.**
- Any changes in enrollment must be submitted in writing and will be approved by the Registrar when space is available.
- Teacher assignments, class sizes and classroom locations are subject to change.
